

#### 1. Certification Flowchart / 认证流程



Note: Different countries may have different procedures and requirements. Certification TAT (Turnaround time) is approximately from 1 week to 1 month depending on the readiness of conformity documents (test report). For complicated product, TAT may be longer.

2. Documentation 资料要求:

2.1 For Saudi Arabia: Application form + Pro-forma Invoice + Test Report + Exporter Business License + Importer Commercial Registration Number + Certificate of Origin. Additional documents are only needed for below certification bodies.

出口沙特需要提供:申请表+形式发票 +测试报告+出口商营业执照+进口商商业登记号+原产地证书扫描件.其它附加文件要求仅限于下述认证公司.

- 2.1.1 For BV (Bureau Veritas), if it is ceramic tile: ISO9001 certificate is required which must be the same manufacturer as shown on test report. 如果产品是陶瓷砖,并且申请的出证机构为 BV, 请提供 ISO9001 证书且抬头必须测试报告抬头一致. (仅限于陶瓷砖, 其它产品不需要)
- 2.1.2 For SGS, Business license of manufacturer is required which must be in the same name as shown on test report. 如果申请 SGS, 请提供生产商的营业执照(与测试报告一致)
- 2.2 For Kenya: Application form + Pro-forma Invoice + Test Report + IDF (Import Declaration Form). Additional documents are only needed for below certification bodies. 出口肯尼亚需要提供: 申请表+形式发票 +测试报告+IDF (入口申报表). 其它 附加文件要求仅限于下述认证公司.
- 2.2.1 For BV (Bureau Veritas), if it is ceramic tile: ISO9001 certificate is required which must be the same manufacturer as shown on test report. Meanwhile, the test report should be within one year from the issuing date.

- 2.3.1 For BV (Bureau Veritas), if it is ceramic tile: ISO9001 certificate is required which must be the same manufacturer as shown on test report. Meanwhile, the test report should be within one year from the issuing date.

- 2.4 The submitted test report shall be CNAS accredited and comply with the requirements of importing countries. If the product is ceramic tiles, the standard shall use ISO13006:2012, EN14411:2012. GB/T4100-2015 Please make sure test report must not be falsely amended otherwise the applicant will be blacklisted by the certification body.

2.5 Final Documents: CIPL (Commercial Invoice and Packing List, format attached) shall be provided in time after shipment in order to prepare and issue the COC. For Iraq or Kurdistan,

- 3. Notice 注意事项:
- 3.1 All marking and instruction shall strictly follow the standards and rules/regulations of the importing countries. If the client's requirement is contradictory with the standard, the manufacturer shall abide by the standard. Otherwise, the inspection may be failed which will result in non issuance of COC certificate. The language of instruction should be in English and Arabic.
